Housing currently (2023) accounts for circa 30% of the UK demand for gas and electricity. We will not achieve our decarbonisation goals if we do not take swift and effective action to minimise and decarbonise the energy we use in our new and existing homes. 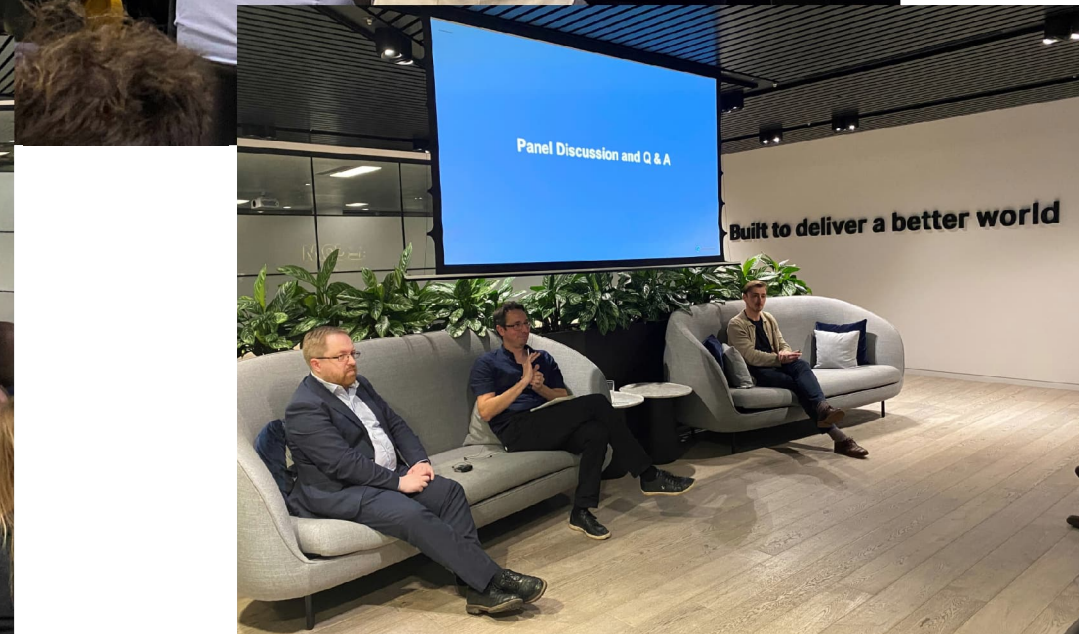
